Verreault, Pierre

For several years, the Canadian Council of Animal Care (CCAC) has contributed to the work of ICLAS in various capacities. Acknowledging the importance of ICLAS' role and mission, I would like, as the CCAC's Executive Director, to contribute firsthand to ICLAS. The CCAC has the dual role of developing standards for the ethical use and care of animals in science in Canada and assessing and certifying institutions using animals in science. Contrary to most countries, Canada does not have a regulatory system for the use of animals in science; it has a peer review system.

The CCAC is now modernizing its program. The CCAC is currently revising its ethics principles. In addition to the Three Rs and ethical use and care of animals in science, the new ethics principles will stress the importance of respect for the animal. The CCAC has developed or is developing three new standards to articulate the new ethics principles. The first standards document is the Categories of Welfare Impact (CoWI) to replace the Categories of Invasiveness. The CoWI standards shift the focus from procedures on the animal to the cumulative life experience of the animal. The End of Study standards document now calls for ethical and deontological endpoints for studies in addition to scientific endpoints to ensure that the animal's life experience is ethically acceptable. The third standards document, Animal Welfare Assessment, was revisited to support the CoWI and the End of Study. Recognizing that animal welfare science evolves and that oversight of animal use in science must keep pace, the CCAC supports ICLAS' mission as "an international scientific organization dedicated to advancing human and animal health and well-being by promoting the ethical care and use of laboratory animals in research worldwide."

Toxicology testing is also a fast-evolving evidence-based science area of interest. In Canada, the government is now adopting legislation to stop the use of animal testing. While such legislations have been in place for several years in other jurisdictions, collaboration is needed to ensure that Canada's policies are harmonized.

I am also interested in using my experience with several national and international organizations to contribute to and promote the objectives of ICLAS.



Voipo, Hanna-Marja

LAS associations have a major impact on developing the welfare of laboratory animals and improving the quality of science.
