


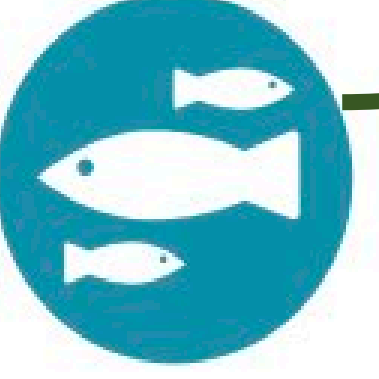

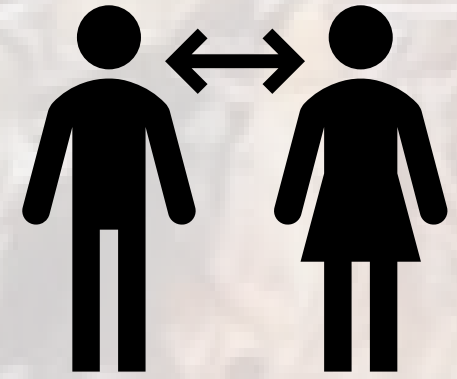

Principle 1: Companies must purchase certified product from a certified supplier

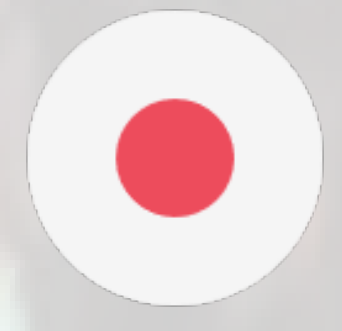



  
Principle 2: Certified products are clearly identifiable

  
Principle 3: Certified products are separated from non-certified products

  
Principle 4: Certified products are traceable, and volumes are recoded

  
Principle 5: The company's management system addresses the requirements of the Chain of Custody Standard
